Results of Screening Questions:

If you answered "YES" to any of the symptoms included under question 1:

- Your child should stay home to isolate immediately regardless of vaccination status and visit an assessment centre to be tested for COVID-19.
- Contact your child's health care provider if you are unsure if testing or another treatment is needed.
- Siblings or other people in your household must stay at home until your child showing symptoms tests negative, or is cleared by your public health unit, or is diagnosed with another illness. Household members who are fully vaccinated or previously positive for COVID-19 in the last 90 days and have since been cleared are not required to stay home.
- Should you choose to not get your child tested, your child must stay home and self-isolate with a caregiver for 10 days, or receive clearance from your health care professional/public health for your child to return to school.

If you answered "YES" to question 3:

- Your child should isolate until the person with COVID-19 symptoms in the household receives a negative test, is cleared by your local public health unit, or is diagnosed with another illness.
- If your child is fully vaccinated and does not have symptoms, they do not need to self-isolate. If your fully vaccinated child develops any symptom of COVID-19, they must self-isolate immediately and get tested.

If you answered "YES" to question 4:

- Your child should isolate for 10 days after last exposure to the COVID-19 case or as directed by Public Health. Follow Public Health's guidance for testing. Your child can only return to school **after** 10 days even if they get a negative test result, as long as they do not develop any symptoms.
- If your child develops symptoms or tests positive, contact your local public health unit or health care provider for more advice.
- If your child is fully vaccinated and does not have symptoms, they do not need to self-isolate. You must inform HS@oakwoodacademy.ca if your child or anyone in your household is a confirmed close contact of a COVID-19 case. If your fully vaccinated child develops any symptom of COVID-19, they must self-isolate immediately and get tested.

If you answered “YES” to question 5:

- Your child should isolate immediately and be tested for COVID-19. If your child tests negative, only then can they return to school.
- If your child develops symptoms, contact your local public health unit or health care provider for more advice
- If your child is fully vaccinated and does not have symptoms, they do not need to self-isolate. You must inform HS@oakwoodacademy.ca if your child or anyone in your household has received a COVID Alert Exposure notification on their cell phone. If your fully vaccinated child develops any symptom of COVID-19, they must self-isolate immediately and get tested.

If you answered “YES” to question 6:

- Your child should remain in isolation until the end of the 14-day quarantine after return to Canada and get tested as per federal requirements
 - This also applies for unvaccinated youth ages 12-17 years of age, even if they are dependents of fully vaccinated travellers.
- If your child is fully vaccinated and does not have symptoms, they do not need to self-isolate for the 14-day quarantine period after return to Canada. If your fully vaccinated child develops symptoms or tests positive, contact your local public health unit or doctor/health care provider for more advice.
- Unvaccinated children under 12 years of age and dependents of fully vaccinated travellers will also be exempt from quarantine; however, they **must** avoid group settings, such as schools, camps or daycares.

If you answered “YES” to question 7:

- Your child should isolate or stay home for the recommended period of time by your public health unit, even if the individual has tested negative. Your child can return to school after they are cleared by your local public health unit.
- Siblings or other people in your household must stay at home until your child tests negative, or is cleared by your public health unit. Household members who are fully vaccinated or previously positive for COVID-19 in the last 90 days and have since been cleared are not required to stay home.

If you answered “YES” to question 8:

- Your child should isolate immediately and visit an assessment centre to get tested for COVID-19. If your child tests negative, they can return to school.
- Siblings or other people in your household must isolate until the individual who tested positive on the rapid antigen test or home-based self-testing kit tests negative on a PCR test or is cleared by the local public health unit. Household members who are fully vaccinated or previously positive for COVID-19 in the last 90 days and have since been cleared are not required to isolate.

Families must fill out and submit a Back to School form to HS@oakwoodacademy.ca prior to returning.

**All previously documented medical conditions listed upon registration will be taken into consideration during screening.*
